New Fees and Charges Bylaw

Due to rising costs, the SV of Ross Haven has revised Schedule A to Bylaw #154 Fees and Charges and increased fees for services provided through our Maintenance operations. Although we try to keep our costs to a minimum, the fees that were being charged have not increased since 2008-2009. The new hourly fees are

available on the Village website under Municipal Information under the Bylaws sub heading. We would also remind residents that the compost



yard is for the drop-off of normal grass clippings and small branches. If you have lake vegetation or branches from major tree trimming, these need to be taken directly to the landfill, or arrange with the Village to have them transported on your behalf at the Fees and Charges rates posted.

2017 Municipal Elections

2017 is an election year for municipalities in Alberta. Summer Villages may set their own election dates, and your Council is working out the procedures for the Council elections this summer. Many changes have been made to the Local Authorities Election Act in recent years. If you are thinking of running for council in the upcoming election, be reminded of the requirement for registration of candidates as outlined in section 147.21 of the Local Authorities Election Act, which came into force on January 1, 2014. As candidates may begin campaign activities for their election and potentially receive campaign contributions or contribute money from their own personal funds for the purpose of the election campaign, the Application for Registration of Notice of Intent to Become a Candidate for Municipal Office (Form 3A) is available on the Municipal Affairs website -

www.municipalaffairs.alberta.ca/am_laea_election_forms Section 147.21(2) requires municipalities to maintain a register of candidates in relation to the election.

Council is eager to communicate with residents. Over the next few months, Council will improve its communications by utilizing the web site and using social media channels to keep residents informed. Onoway Regional Medical Clinic

The Summer Village of Ross Haven has entered into an agreement with Lac Ste Anne County and other surrounding towns and villages to operate the Onoway Regional Clinic. This new clinic will ensure our resident swill have access to local medical professionals. The new clinic opened in Onoway on Jan 3, 2017 with 2 fulltime equivalent doctors on staff.

Ross Haven Community League

The Ross Haven Community League has a history of hosting events in the Village, whether it be Canada Day Celebrations, or the New Years Eve party on the lake. The Ross Haven Community League has also worked to bring exercise equipment to the park and installed two Little Free Libraries in the park where you can take-a book, leave-a book. We thank the Summer Village for providing funding support for many of these projects through FCSS grants now administered by the Village. In 2016, the Community League accessed approximately \$6,800 from these provincial funds that are now made available to the Community League, through the oversight of the Village Council.

Planning is underway for another celebration for Family Day, to be held February 19, 2017. Enjoy horse drawn Hay Ride, Beef on a Bun, and Hot Chocolate! Events will start at 1 PM in front of the Village Maintenance Shop
