#### **BYLAW NO. 295-2022**

#### SUMMER VILLAGE OF ROSS HAVEN

BEING A BYLAW OF THE SUMMER VILLAGE OF ROSS HAVEN, IN THE PROVINCE OF ALBERTA, TO RESCIND A BYLAW THAT IS NO LONGER IN EFFECT.

WHEREAS, pursuant to Section 7 of the *Municipal Government Act, R.S.A. 2000, Chapter M-26*, the Council of the Summer Village of Ross Haven may pass bylaws for municipal purposes; and

WHEREAS, Section 191 of the *Municipal Government Act, R.S.A.* 2000, Chapter M-26, states that any amendment or repeal of a bylaw must be made in the same manner as the original bylaw; and

WHEREAS, the Council of the Summer Village of Ross Haven deems it expedient for administrative purposes to remove bylaws which should no longer be in effect, but which were not officially rescinded by subsequent bylaws dealing with the same item;

**NOW THEREFORE**, the Council of the Summer Village of Ross Haven, in the Province of Alberta, duly assembled, enacts as follows:

1. That the following bylaw will be officially rescinded on the date of final passing of this bylaw:

Bylaw 204-2006 A Bylaw of the Summer Village of Ross Haven in the Province of Alberta to govern the control of animals within the municipal boundaries.

2. That this Bylaw shall come into force and effect on the date of third and final reading.

#### Collaboration with LSAC

- o Followed up with Joe on the agreed upon next steps.
- Monday, December 5 Met with Greg Edwards (County, GM of Infrastructure and Planning)
  - RR34 Quote for geotechnical survey should be signed off by Dec 8. County paying 100% of this. Test drills should be completed within 2 months. Once recommendation received, a more detailed estimate will be completed, and then SV of Ross Haven and LSAC will discuss cost sharing arrangement. If both councils agree, work could commence September 2023.
  - CPO Services Initial agreement should be available to Ross Haven council before Christmas.
  - Weed / Pest Control, Assessment, and FCSS Initial agreement should be available to Ross Haven prior to end of Q1 2023.

#### Sewer Project

- As of this meeting, work is completed on third street, and has moved to second street.
- O Hoping for completion by end of January need good weather to allow them to finish second street, Parkins Ave, and RR34. Likely will spill into February. They will return in spring for landscaping.
- Encourage residents to get pricing for the homeowner part of the system! Several have already completed this portion. Sounds like we have several others that committed to the work.
- Nov 18, 2022 Attended Sewer Line Construction Meeting (Telephone).
- Dec 2 Meeting Cancelled.

- Drainage issues on parkway between 8<sup>th</sup> Street and 9<sup>th</sup> Street.
  - Council approved the go ahead to complete the survey and commence engineering
- Portion of 8<sup>th</sup> street that runs parallel to lake.
